3. I understand that on my death that the right of burial will pass in accordance with the estate of the person named above and that I hold the same on behalf of the said estate and not in my own right.

4. I hereby indemnify the General Cemetery Company of Dublin against any claims, costs and expenses howsoever arising on account of its reliance on this declaration by me.

I make this Solemn Declaration conscientiously believing the same to be true, for the satisfaction of the General Cemetery Company of Dublin and in conformity with the Act of Parliament 4 & 5 William IV., Chap. 65 and the Bye-Laws, Rules and Regulations of the General Cemetery Company of Dublin and by virtue of the Statutory Declarations Act 1938.

The personal representative holds it on behalf of the estate and on his or her death it passes back into the estate of the original owner and not into the estate of the personal representative.

NOTICE

The completion of this Declaration will obviate the necessity of Probate of Will, or Letters of Administration being exhibited at the Cemetery Office. It should be signed before a Notary Public / Peace Commissioner / Commissioner for Oaths / Practising Solicitor and forwarded to the Secretary of the Cemetery within 14 days, with

Registration Fee €....., following which a Certificate of new ownership will be issued.

Only One Owner will be Registered and Recognised by the Company.

Explanation of Derivative Assignment (DA) Declaration

There are 2 parties to this DA declaration:

1. **The Declarant:** this is the individual who wishes to complete this declaration and become the new owner of the exclusive right of burial in a grave. The Declarant must complete the top half of this (DA) declaration. The Declarant must only sign their name in the presence of a witness.
2. **The Witness:** Only one of the following individuals is accepted as a witness to the signature of the Declarant:
 - Notary Public
 - Peace Commissioner
 - Commissioner for Oaths
 - Practising Solicitor

The Witness must complete the bottom half of this declaration below where the Declarant has signed their name.

The completed DA declaration must be forwarded to the Secretary of the Cemetery with the registration fee. A Certificate of new ownership will then be issued to the new owner.
